
American Rescue Plan Act





FEBRUARY 2022 UPDATE



ARPA FUNDING BACKGROUND

ARPA FUNDED PROJECTS MUST FALL UNDER ONE OF THE FOUR LISTED CATEGORIES



Respond to public health emergency or its negative economic impacts including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality



Government services to the extent of the reduction in revenue due to the COVID-19 public health emergency relative to revenues collected in previous years (not applicable to EPC)



To make necessary investments in water, sewer, or broadband infrastructure



Premium pay for eligible workers, performing essential work during the COVID-19 public health emergency

GRANT PROGRAM REVIEW

- Custom grant applications were developed for each category
- Initial allocations for categories were identified
- Staff review committees thoroughly reviewed all applications received
- Each category was assigned a Commissioner Liaison for oversight
- Applicants were reviewed for ARPA and program eligibility
- All applicants were scored using a detailed custom rubric by the committee
- Committee grant recommendations were presented to the Commissioner Liaison for approval

REGIONAL BUSINESS RELIEF FUND

COMMISSIONER LIAISON - STAN VANDERWERF

- Economic development awarded two rounds of funding through the El Paso County Regional Business Relief Fund.
- 627 businesses were funded for a total of \$10,381,441
- Of the 627 businesses funded, 525 were small businesses and 102 were nonprofit organizations

501(c)(4) & (6) GRANT

COMMISSIONER LIAISON - STAN VANDERWERF

- Grants for Chambers of Commerce (501(c)(6)) and Business League Organizations(501(c)(6)) focused on regional tourism efforts and Non-lobbying (501(c)(4)) with an economic driven mission. Grants can be used for various purposes outlined in the program, that promote economic recovery for the region in the areas of business support services or tourism industries.
- 11 applicants were funded for a total of \$2,703,700

TOURISM & HOSPITALITY FACILITIES GRANT

COMMISSIONER LIAISON - STAN VANDERWERF

- Grant was available to both for and nonprofit entities. Funds may be used for planned expansions or upgrades to tourism and hospitality facilities delayed due to the pandemic and COVID mitigation efforts
- 8 applicants were selected for funding; \$2,087,700

COMMUNITY IMPACT GRANT


COMMISSIONER LIAISON - CAMI BREMER

- Grant was open to non-profit 501(C)(3) organizations. Funds may be used to create/expand programs meant to provide a wide range of services that respond to the pandemic while addressing the public health and economic challenges associated with such.
- 50 applications were selected for funding; \$8,954,635

WATER INFRASTRUCTURE

COMMISSIONER LIAISONS - HOLLY WILLIAMS & LONGINOS GONZALEZ, JR.

- Forsgren Associates Inc. has been selected to assist with the development of the water projects
- Notice of Interest is open until full application is developed
- Received 20 notice of interests to date



STORMWATER INFRASTRUCTURE

PUBLIC WORKS PROGRAM

- El Paso County Department of Public Works has identified 7 stormwater projects totaling \$10 million
- An additional \$5 million has been allocated for projects that are yet to be determined
- Preliminary project timelines are between 18-33 months

BROADBAND INFRASTRUCTURE

COMMISSIONER LIAISON - CARRIE GEITNER

- The ARPA Fiber Program will construct middle mile infrastructure to connect County facilities and create opportunities for partnerships with last mile commercial broadband providers with a goal of improving availability, speed and price for underserved/unserved El Paso County residents
- County facilities to be connected include the Calhan Area Campus and Public Health South for an estimated \$4.5 million and \$1.5 million respectively


ROAD INFRASTRUCTURE

ROADWAY PROJECTS

- ARPA Final Rule provided a provision to take a one-time standard allowance of \$10 million dollars to fund government services - including roads
- \$10 million is in addition to the \$14 million appropriated to roads during the 2022 regular budgeting process, for a total of \$24 million




TOTAL ALLOCATION \$139.9 MILLION
