
Organizational Chart:

- The El Paso County Assessor's Office currently has 51 Full Time Employees and 1 Part Time Employee
 - One of the smallest staffed metro offices
 - Largest county with over 300,000 parcels
 - El Paso County is continually in top 10 National real estate market last 5 years
 - Providing more to our citizens with less



Valuable Assets:
