The meeting was called to order at 9:30 a.m.

#### Members Absent at the February 8, 2021 COG Meeting

A motion was made to accept the absence of CheyAnne Clemmons and Sarah Brittain Jack as an unexcused absence, it was seconded, and all members present were in favor (7-0) (with two members absent and two openings to be filled). However, shortly after this vote, Sarah Brittain Jack joined the meeting and a motion was made to amend the absent action item to remove Sarah from the unexcused absence vote. It was seconded, and all members present were in favor (8-0), (with one member absent and two openings to be filled).

Natalie Sosa, Deputy Public Information Officer welcomed each of the 2021 Citizen Outreach Group members and introduced the new District 4 COG member, Jim Godfrey, and District 5 COG member, Lauren Hug. Each of the COG members and COG staff then introduced themselves.

#### Election of COG Officers for 2021

A motion was made to renominate Stephanie Adams as Chairperson of the COG for 2021. With no further nominations the motion was seconded, and all members present were in favor (8-0) (with one member absent and two openings to be filled). Stephanie Adams accepted.

A motion was made to nominate Lauren Hug as Vice Chairperson of the COG. With no further nominations the motion was seconded, and all members present were in favor (8-0) (with one member absent and two openings to be filled). Lauren Hug accepted.

## Administrative Items

- 1) A motion was made to approve the October 12, 2020 meeting minutes as written; it was seconded, and the minutes were approved unanimously by all members present (8-0), (with one member absent and two openings to be filled).
- 2) Legal Overview by Steven Klaffky, Senior Assistant County Attorney

By statute the County Attorney's office exists to provide legal service to the Board of County Commissioners, all the County Elected Officials, and to any duly constituted advisory board that they set up to help them do their job, which is exactly what the Citizen Outreach Group is. The County Attorney is in place for their convenience and for their legal advice (for things within the course and scope of what this body is doing).

Steven provided a brief overview of the policies and procedures of the Colorado Open Meetings Law which is statutory. El Paso County is a statutory county and follows the Colorado statutes. Requirements for openness and transparency that inure to the Board of County Commissioners extend to the Citizen Outreach Group as a local public body.

- The Colorado Open Meetings Law applies to any meeting of a local public body wherein public business is discussed.
- COG is a local public body with eleven voting members. Whenever three or more of this public body is present and there is any conversation considered to be public business, the open meeting laws apply.
- COG members can meet in the public but avoid the topic to discuss public business. If discussions occur between COG members regarding ideas pertaining to the COG, then the members must leave whatever official action taken during that meeting undone to avoid any violations.
- Correspondence through e-mail pertaining to public business must abide by the open meeting laws as well. Group e-mails amongst COG members are not permissible if discussing public business. This applies to text messages as well. Communications via email and phone messages (private computers and phones) are subject to CORA should a request be made only to the extent those communications relate to public business of COG.
- Public notices will be posted 24 hours in advance of each meeting and will be posted on the El Paso County website at: <u>https://www.agendasuite.org/iip/elpaso;</u>
- Regular meetings are scheduled from 9:30-11:00 a.m. in the Pikes Peak Conference Room of the County Administration Building, Centennial Hall, 200 South Cascade Avenue, Colorado Springs, CO, or via a virtual meeting. A proposed meeting schedule and agenda is provided to the COG at the beginning of the new year and posted on the Citizen Outreach Group website page:
